Summary of June 22 JLMBC meeting

#### 1. CalPERS Final Renewal Rates for 2018

- a) Review modeling options for employee contributions
  - Lockton advised final CalPERS rates for 2018 increased by only 1.2%, with impact to Rate Stabilization Fund (RSF) of \$328,130.
  - There will be no employee contribution rate increase for 2018
- b) CalPERS New Plans and Rates for 2018
  - New HMO Plan: Western Health Advantage
  - New Medicare HMO Plan: Anthem Traditional HMO
  - Open Enrollment is from September 11-October 6.

#### 2. CalPERS Plan Changes for 2018

Following are changes approved for 2018 PPO Plans:

- a) Expand Value Based Purchasing Design Program (aka ambulatory settings vs hospital settings) by adding 12 new procedures.
- b) Site of Care Management for Medical Pharmacy
- c) Reduce use of Emergency Room for Urgent Care
- d) Continue and Expand PPO Purchasing Tools
- e) Silver Sneakers Program

### 3. Universal Life Insurance Option

- a) Committee discussed whether to offer this voluntary program to its members. FA would like to offer the plan to all PT faculty with 50% or higher load, with Reemployment Preference.
- b) Lockton will get back to the Committee after talking with TransAmerica.

## 4. Post 97 Bridge Program

- a) Unions had previously proposed that all post 97 employees who take part in the Bridge Program have the District contribution tied to Range M/Step 8, the same as managers.
- b) The District said it agrees that all employees should get the same rate and handed out a three year plan to get there.
