District Benefits Report - Susanne Wong Chan

CalPERS Report to FODARA Board - JLMBC Meeting July 27, 2023

- The last meeting of JLMBC for academic year 2022-2023 took place July 27, 2023, via Zoom
- Members of the Negotiating team representing the bargaining groups,
 Administration and Consultants from Lockton group continued their discussion regarding medical benefits for the groups
- Previous meetings had reviewed research data which showed significant increases in premiums. Alternatives to CalPers had been discussed
- Bottom line, to change out of CalPers and to contract with comparable "brokers" or consortium groups would cost more due to punitive "withdrawal" fees rather than to remain with CalPers.
- Like other price increases of the past few years felt by everyone, premiums for medical benefits will also increase
- It is vitally important that all retirees read through the information regarding Open Enrollment for medical benefits options that has been sent out by CalPers. Some increases are higher than others. Be prudent and gain understanding of personal medical benefits and needs.
- When active employees return to work in fall, they will be asked to ratify new contracts for the bargaining groups. The District has proposed picking up 85% of the medical plans' cost. Retirees will wait for the results from these votes.
- The groups broke out to caucus some specific aspects from the negotiations. It was a privilege for George Robles and me, Susanne Chan to listen in awe to the Employee Negotiating Teams SEIU and FA, whose knowledge and advance planning of strategies was amazing; Personally speaking, I am grateful to have them on "our" side!
