### a. Review Remote Attendance Policy – Singh

- c. President Torres announced IEPI funding for noncredit, with a portion designated for professional development for Curriculum Committee members – Singh
- Bliss – expanding noncredit and dual enrollment and a portion of the funding will be used for faculty professional development. The State is creating a team that will be start in the fall for this work to happen.
- d. DEI in COR – Bliss/Judson

  - The goal is to come up with a list of what the committee would feel comfortable recommending to start looking for DEI in consideration of each division/depart/discipline to look for.
  - The goal is to add a DEI stage in a future workflow to assist in the mandatory inclusion of DEI per Title V. Also possibly add a tab in eLumen for initiators to identify DEI elements in their COR.
  - Options:
    - Free or low-cost text book
    - Diversity in the types of assignments
    - Examples of specific assignments involving DEI
    - Update the choices in the methods of instruction
    - Diversity of methods of evaluation
    - Collaborative projects (choices being made available students)
    - Student choice in assessment
    - “Warm” and “Welcoming” language
    - Course descriptions should be easily understand (avoidance of jargon)
    - Representation (cultures, genders, ages) in the outline
    - Range of perspectives of authorship
  - Next steps would be to expand and write up the options to bring back to the committee for a first draft. Then post it on Curriculum’s website. Then generate a letter to faculty to inform them of what CC will be looking for in curriculum.
